#### A. 研究概要

S. Carpi, R. Longo と共に super conformal field theory への作用素環的アプローチを研究した。Super Virasoro algebra については central charge が  $3/2$  未満のケースについて離散的な表現の列を持つことが知られているが、このケースについて、作用素環の super Virasoro net を coset net として実現し、その延長を調べることにより、super conformal net の分類を行った。これまで我々が展開してきた一般論のほか、Gannon-Walton による modular invariant の分類手法を道具として用いる。

We have studied operator algebraic approach to super conformal field theory with S. Carpi and R. Longo. It is known that the super Virasoro algebras have discrete series of representations for central charges less than  $3/2$ . We have realized the super Virasoro nets of operator algebras for these cases as coset nets and obtained a classification result by studying their extensions. Together with general theory we have established, we also use the classification technique of modular invariants given by Gannon and Walton.
